- **Training and Competency:** All personnel must be trained, competent, and possess valid certificates for scaffolding and working at heights.
- **Risk Assessments:** Perform risk assessments, create Safe Operating Procedures (SOPs), and conduct Planned Task Observations (PTOs).
- **Defects and Failures:** The service provider must rectify any defects or failures at their own expense if not caused by the mine.
- **Vehicle and Equipment:** Provide suitable vehicles and equipment, ensuring compliance with safety standards.
- Housekeeping: Maintain a clean and safe work environment.
- **Working Hours:** Standard working hours are from 06:00 to 18:00, five days a week. Callout services must be available outside these hours.

Team Availability: The scaffolding team should be located within a proximity of the Belfast mine operations to respond within 2 hours of a callout.
